# 5. FIREFIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

# 7. HANDLING AND STORAGE

Close container after each use. Ground containers when pouring. Do not transfer contents to bottles or unlabeled containers. Wash thoroughly after handling and before eating or smoking.
