EXTINGUISHING MEDIA:

SUITABLE EXTINGUISHING MEDIA:

PREVENT ENTRY INTO SEWERS, WATER COURSES, BASEMENTS OR CONFINED AREAS. WASH SPILLAGES INTO AN EFFLUENT TREATMENT PLANT OR PROCEED AS FOLLOWS.
